## Explanation of Responses:

1. On February 1, 2021 the reporting person received 10,051 restricted stock units, one-half of which will vest on the first anniversary of the grant date, and one-half of which will vest on the second anniversary of the grant date.
2. The stock option vests as to 25% of the shares on the 1st anniversary of the date of the stock option grant and as to an additional 6.25% of the shares each successive three month period thereafter.
3. On February 24, 2021 the reporting person also received 3,629 performance stock units that will vest upon the later of (i) the one-year anniversary of the grant date and (ii) positive topline results in a specific clinical development program, which will be reported on a Form 4 when the shares are released.
